- Chauffeured only; 4-hour minimum.
- Hourly rates are all-inclusive (includes driver, 20% gratuity, delivery, taxes, tolls, mileage, fuel, parking, etc.)
- 25% U.S. holiday surcharge applied to total rental price on: July 4, Labor Day, Memorial Day, Christmas Eve/Day, New Years Eve/Day, Thanksgiving Eve/Day.
- A non-refundable deposit of 50% of total rental price is required to hold a reservation. Remaining balance is due 7 days before rental date.
- Cancellations with less than 48-hours notice and no-shows at time of rental will result in a cancellation fee of 100% of total rental price.
- Any additional service beyond the contracted time period will be charged at the hourly rate with no pro-rata or grace period.
- Capital Dream Cars's self-drive policies, advance booking discounts, and other promotions do not apply to our exclusive provider's chauffeured vehicles.
- Capital Dream Cars and our exclusive provider are professional organizations that attend to clients and their needs with the utmost care. At the same time, we may not be held responsible for lost or damaged baggage, personal belongings, or any items left in vehicles.
- Vehicle code of conduct: (a) No alcohol consumption by anyone under age 21; (b) No smoking inside vehicle; (c) Clean-up fee for spills/excessive trash assessed at \$200; (d) Driver has the right to drop off disorderly persons or remove vehicle from dangerous situations (threat to persons or property) at his sole discretion.

As such, the Client hereby agrees to indemnify and hold harmless Capital Dream Cars and its parents, subsidiaries, agents, respective officers, directors and employees ("Capital Dream Cars") from and against all liabilities, obligations, losses, damages, penalties, claims, actions, suits, costs, charges and expenses (including legal counsel and expert witness fees/expenses without limitation) which may be directly or indirectly imposed upon, asserted against or incurred by Capital Dream Cars by reason of actual or alleged personal injuries, property damage, wrongful death or any other damages resulting from or occurring during the rental period.
